## Introduction

*In 2017 the Peace Institute has continued to develop research and advocacy within four thematic fields: 1) politics, 2) human rights and minorities, 3) media and 4) gender.*

In the context of *human rights and minorities*, taking into account the situation in Slovenia, a number of activities focused on migration, where we studied the role of the EU and Slovenia in dealing with migration, criminalization of migration and the situation in the field of integration. We collaborated with other stakeholders to facilitate the integration of migrants and refugees into the labour market. At the beginning of the year, we participated in the campaign against amendments to the Aliens Act, which allowed the parliament to close the border completely for all migrants, including asylum seekers, which counters the accepted international obligations of Slovenia. We prepared a series of workshops and public events on the subject of awareness-raising in relation to migration and refugees. For example, on March 2, we co-organized a roundtable "The Aliens Act as a Symptom of the Autocratic Authority?", on March 13 we organized a roundtable "A migrant as a political subject in the global era of disappearance of politics", and on August 31 we held a roundtable "Solidarity on the Challenge: how do migrants see us and how we see them."

We continued to coordinate the Council to Respond to Hate and Discriminatory Speech, even after the project expired in February 2016. In 2017, the Council finished its mandate. In the framework of the eMORE project, which also addresses this topic, on June 15 we organized a roundtable titled "Hate Speech on the Web – to ignore, monitor or act?" We also released two short films – "Negativ", which depict the fates of rejected asylum seekers, and a short film about hate speech, which was created on the basis of a workshop with high school students.

Despite the expiration of all projects in the field of the *erasure*, as well as the expiry of all deadlines for compensation

and for special options for regulating the status, we still offered advice to the erased people in case of need. Most of the proceedings before the European Court of Human Rights regarding the *erasure* were concluded in 2017 without any substantive result, as the court decided not to deal with these complaints in merits. Related to the issue of erasure, we identified a special problem on the lack of possibilities for regulating the status of people who live in Slovenia without papers for many years or even decades. This group comprises of either the erased people, non-returnable rejected asylum seekers, or other individuals who are present in Slovenia for various reasons and cannot go anywhere else. In such cases, in cooperation with the Police, we helped the people to regulate *permissions to remain*, which is by law the only option for protecting people from expulsion and gaining access to basic care. We also informed the Ministry of the Interior and the Human Rights Ombudsman about this problem.

In 2017, we continued with the implementation of four partner projects in the area of criminal law, specifically regarding access to legal assistance during police detention and during criminal proceedings before the courts, and access to legal assistance for defendants with mental health problems. In the framework of another new project, we started to deal with the rights of victims of crime. The work in this field will be upgraded with another newly acquired project on the role of national institutions for the protection of human rights.

In the field of *politics*, on May 9 we organized a roundtable titled "Modern state, power and violence", which addressed the question whether it still makes sense to discuss the ethical and political idea and the notion of the state when the combination of neoliberal and xenophobic states is becoming an increasingly global mainstream. By conducting a Seminar

on Political Theory, we nurtured the political thought and organized a space for connecting young people with the Peace Institute. We continued to carry out the Bystanders project, in which we promoted the responses of witnesses of sexual harassment among young people. A conference on global learning, which we organized on November 22 together with association Humanitas, was a highlight. In the framework of the SUSY project, we prepared a study on the solidarity economy. On June 19, we organized a public discussion entitled "Social and Solidarity Economy: What Kind of Economy Can Exist beyond Capitalism?", and on September 21, we co-organized a seminar "Silent De-growth and Loud Thunder: Views from European Half-Periphery". We have also joined the pan-European EMIN2 project on minimum income and poverty risk.

In the field of *media* we studied mediatisation, media in connection with uprisings and gender differentiation in the media industry. We carried out raising awareness of the responsible use of the media by young people, and we continued to work on strengthening the respect of media standards in the Western Balkans region. In this context, we carried out the final year of the project on the EU investigative journalism awards in the seven candidate countries for EU membership.

In the field of *gender*, there were a number of projects implemented on work-life balance, fatherhood, care work, and unpaid work of women. At public events and in the media there were also many appearances that were based on our past projects in the field of gender. A release of the book on the comparison of prostitution regimes in Slovenia and Croatia was very visible. On May 22, a public event "Prostitution in Slovenia and Croatia" was organized.


Of the other activities, at least two events should be highlighted. Co-founder and co-worker of PI Vlasta Jalušič was invited by Heinrich Böll Stiftung and the City of Bremen, to hold a laudation to Étienne Balibar when he was bestowed the Hannah Arendt Award for 2017. We also launched an online petition calling for the authorities to ratify the UN Nuclear Arms Ban Treaty. In 2017 we also received the public interest status in the field of protection against discrimination and protection

of human rights, which was granted to us by the Ministry of Labour, Family, Social Affairs and Equal Opportunities on the basis of the Protection against Discrimination Act.

Most of the research activities, public events and advocacy actions took place in the framework of pre-set projects, while some individual activities were carried out irrespective of project financing. In 2017 we carried out 42 projects (to compare, 36 were carried out in 2016, 33 in 2015, and 41 in 2014). Seven of them were financed by the Slovenian Research Agency (ARRS) and 27 by the European Commission and other EU agencies. Other projects were financed by the Open Society Foundations, Norwegian Financial Mechanism, Ombudsman of the Republic of Slovenia, Ministry of Foreign Affairs, Ministry of Labour, Family, Social Affairs and Equal Opportunities, Government Communication Office, European Stateless Network and Independent Social Research Foundation London. The number of employees (16) remained unchanged in 2017 compared to 2016. Of these, eight hold a PhD, while three have a Master's degree. Three associates are doctoral candidates.

We estimate that such number of projects enables the PI a normal and publically visible research, academic and advocacy work, without using reserves. However, this number of projects also caused a significant workload for employees. In the vast majority of projects we participate as partners which provides for limited resources for further development of the institute and its staff. The development of the institute and new jobs are mainly provided by projects in which the PI is a lead organization, so in the future it is important to seek to increase the latter.

### AIMS AND GOALS

### AIMS AND GOALS

The main focus of the project is researching socially unacceptable discourse (SUD), i.e. hate, discriminatory, offensive or threatening speech. The project combines state-of-the-art quantitative and qualitative multidisciplinary approaches, such as the methods of corpus linguistics, critical discourse analysis, legal analysis and sociological survey methods, employed to research the use and perception of socially unacceptable communication in its sociocultural context. In addition, through the use of exploratory and inferential statistics as well as statistical modeling, the proposed novel data-driven approaches on unstructured and semi-structured datasets will move the frontiers of the traditional humanities and social sciences. The project has a strong empirical basis, as most research is performed on large corpora of Slovene SUD and CMC, which will be automatically annotated for the phenomena of interest. To develop the required automatic annotation methods, we will produce manually annotated datasets and train machine learning (ML) methods to build predictive models of the researched phenomena.

In 2017 project website was set up (see: <http://nl.ijs.si/frenk/english/>), partners prepared a panel proposal for an international symposium, partners cooperated in joint implementation of public awareness-raising on how to address hate speech and we worked on construction of corpora which will allow empirical research in the project, and includes linguistic processing and enrichment of metadata in the corpus, etc.

#### AIMS AND GOALS

The project addresses the problem of the criminalization of migration which is visible in the strengthening of border control institutions (border police and Frontex with large IT surveillance systems), militarization and externalization of border control, confinement of irregular migrants in detention centers, lack of alternatives to detention, antiterrorist laws, penalization of irregular border crossing and disproportionate representation of migrants in prisons.

#### REALIZATION IN 2017

In the second year of the project we focused on field research that was carried out in various geographies (in Slovenia, other EU member states, Western Balkans, and states that are at the EU borders or at the Mediterranean). The field research was carried out based on various methodologies. First a questionnaire prepared in two languages was further adapted to the types of respondents. Interviews were carried out on the basis of those questionnaires. For the legal research a special methodology was prepared: 1) an excel chart for the identification of sanctions related to migration (for Slovenia and WB), 2) specific expert template for five consultants from WB for the preparation of written responses, and 3) a special questionnaire for oral interviews focused on legal aspects. We regularly carried out the meetings of the project team, reviewed the work done and planned further steps. We published an international Call for Abstracts for a conference to be held on 17-18 May 2018 in Ljubljana. We submitted an edited volume to the international publishing house Cambridge Scholars Publishing that contained contributions of a number of colleagues from the project team.

The NPM is an independent national body whose members visit persons deprived of their liberty as well as those places where these persons are detained. The NPM aims to strengthen the protection of persons deprived of their liberty against torture and other cruel, inhuman or degrading treatment or punishment.

### REALIZATION IN 2017

#### In 2017 we participated in 12 NPM visits:

8x premises for police detentions, 3x homes for the elderly, 1x prison. After each visit we have submitted our observations to the Human Rights Ombudsman, in three cases we have taken the lead in writing the report. Additionally we have written the chapter on Center for foreigners for NPM yearly report for 2016.

### AIMS AND GOALS

The project, launched in June 2016 and funded by the European Union, aims to increase understanding of the shortcomings and dysfunctions in each national criminal law framework on the issues addressed by Directive 2013/48/EU on the right of access to a lawyer and Recommendation C(2013) 8179/2 on the right to legal aid among key stakeholders in 5 EU jurisdictions, and to identify and promote examples of transferable good practice. The project also aims to facilitate communication and coordination between legal practitioners and to build and strengthen the capacity of stakeholders on the international and EU standards on the rights to access to a lawyer and legal aid of suspects and accused in criminal proceedings.

### REALIZATION IN 2017

In 2017 we continued and completed the analysis of 150 case files, which was a key research activity. We organised two focus groups with criminal defence lawyers and conducted interviews with judges, police officers and inmates. On this basis we prepared the national report.

### ANNOUNCEMENT OF PROJECT CONTINUATION

In 2018 we will finalise a handbook, which will comprise international standards concerning access to a lawyer and legal aid and key findings of the national study. ### AIMS AND GOALS

The overall aim of the project is to identify good-practices, as well as gaps and shortcomings of each project partner's national criminal justice system (Austria, Bulgaria, Czech Republic, Lithuania, and Slovenia) with regard to the implementation of the Recommendation and to elaborate recommendations at the national and EU-level. It strives to enhance the awareness and capacities of professional stakeholders involved in criminal proceedings (in particular law enforcement authorities, legal practitioners, medical personnel, the judiciary, NGOs and representatives of persons with intellectual and/or psychiatric impairments) to understand the complex situation and barriers of these persons.

### REALIZATION IN 2017

In 2017, in collaboration with Altra, an NGO with extensive experience in the field of mental health, we conducted semi-structured interviews with final beneficiaries, persons with intellectual and/or psychiatric impairments who were suspects or the accused in criminal proceedings to explore their experiences and needs.

We organised a workshop, attended by NGO representatives, representatives of academia, Human Rights Ombudsman, police, psychiatrists and psychologists, social workers and lawyers. Participants shared with us their experiences and views on the situation of final beneficiaries in the Slovenian criminal proceedings. Based on our research, we prepared our National Baseline Study. In Vilnius, the European workshop took place, where we discussed outcomes of national research and recommendations.

## ANNOUNCEMENT OF PROJECT CONTINUATION

The main project challenges were to consolidate everyday work with all needs (individual and community needs) appearing on daily basis in the work with asylum seekers and refugees. The establishment of Second Home helped us to work with our target groups, to promote more horizontal approaches and develop self-organized methods of work. The main lesson is the fact that the "workshop" approach does not work and that the primal focus should be on the employment of refugees, asylum seekers or migrants. This kind of approach focuses more on the needs of the target group and builds trust faster. The biggest problem, however, is a lack of any proper action from the Slovene government, and the fact that Slovenia still didn't prepare the contingency plan and the refugee integration strategy. We will continue to advocate for improved integration of refugees and migrants in general and Gmajna will continue to assist people with integration. We will remain engaged in education and awareness-raising of the general population in Slovenia. Clearly the needs are still here. In 2018 we will strive to get funding to continue our work in this field.

### AIMS AND GOALS

The project stems from an urgency to examine the disparities in outcomes of ethnic minorities in Criminal Justice Systems (CJS) across EU Member States. The injustices and discrimination faced by minorities are visible in labour markets, where they are disproportionately affected by economic and financial crises, and also across CJS, wherein minorities are consistently overrepresented in terms of incarceration and arrest-rates. The objective of the project was to examine existing sources on ethnic disparities in criminal justice systems.

### AIMS AND GOALS

The aim of the project was to educate and empower 450 to 550 pupils in secondary schools in Slovenia in recognizing hate speech, critical and responsible media use and about migrations.

### REALIZATION IN 2017

In the period from 1 April 2017 to 31 October 2017, we conducted 25 workshops in five different secondary schools and school centers. More than 630 pupils and students attended the workshops. Key activities included the preparation of an educational module based on the concepts of human rights and intercultural media education; the implementation of workshops lasting 90 minutes and intended for secondary school students; and the evaluation of the project and workshops on several levels (by the expert for these fields, students and educators). The workshops also included persons with a migrant background.

### ANNOUNCEMENT OF PROJECT CONTINUATION

The evaluation of the workshops showed that we achieved and exceeded the given educational goals, and that the students assessed them after the performance with an average grade of 4.1 (on a scale of 1-5). After the workshop, most of the students responded that their reception of information by the media and other sources would be more critical (average grade 3.5), which was one of the educational goals of the workshop. The results show that students were equipped with adequate information on migration, as the vast majority did not agree with the claim that migrants would have more rights than Slovenian citizens (2.5). After the workshop, most of the students considered that in their class and at school they should do more for tolerant relationships (3.3), meaning that we have sensitized a large part of the participants, since the majority before the workshop considered that hatred and intolerance in their school community is not a problem.

Except that we have met the set goals, we estimate that the added value of the project is primarily in providing young people with information and competencies that are important for orientation in contemporary societies. The project also contributed significantly to the professional development of all involved, especially both researchers, who were in direct contact with young people from different social backgrounds. We point out that the project provided an opportunity for people with migration experience to express their views without intermediaries. Teachers who attended the workshops will be able to multiply the acquired knowledge and experience in the future. New competences and knowledge in the field of project work were acquired by volunteers.

In 2018, we want to continue the implementation of this good practice, by strengthening the most effective pedagogical approaches, in particular the participation of migrants and refugees, and by expanding the choice of topics, methods and activities that schools can choose from.

### AIMS AND GOALS

MEET aims at promoting a critical and inter-cultural understanding as well as an aware use of media among young citizens in multicultural public schools in democratic societies. It mainly addresses economically and socially disadvantaged youth (aged 13-19), including migrants and refugees, by engaging them and their teachers in an action research process to co-design and develop inter-cultural media education practices inspired by principles of equity, tolerance, social justice and solidarity. In this respect, MEET can be seen as an educational (or pedagogical) challenge to a broader culture of exclusion, exclusivism and discrimination that nowadays seems to permeate many political discourses and media representations, as well as the widespread neo-liberal reconfiguration of educational provision. Finally, the project intends to advocate Media Education as a means to support social inclusion/justice among different sections of the public and through several dissemination tools, from the production of an educational documentary to the spreading of policy recommendations, digital toolkits and scientific papers on media and citizenship education.

### REALIZATION IN 2017

Research on policies from the fields of citizenship, media and intercultural education has pointed to a shift in policies that at the declarative level address just and inclusive education but also show exclusivism and Eurocentrism, as a response to migration and terrorism. We have produced national and a comparative reports within the workpackage coordinated by the Peace Institute. Further, we have designed, together with teachers, media education materials for critical media literacy and culture of justice and equality in selected multicultural schools in three countries (Italy, Germany and Slovenia). In Slovenian context we have chosen two schools where we will conduct field research and where we have tested the learning materials: Dvojezična srednja šola/Kétnyelvű Középiskola (Lendava, SL) and Srednja šola tehniških strok Šiška (Ljubljana, SL).

## Mediatisation of Public Life: Controversies in the Sphere of Politics and Everyday Life

### AIMS AND GOALS

The proposed project responds to a pressing need for theoretical rethinking to better understand whether, and in which respects, various components and aspects of society and everyday life are becoming more mediatised, and in what sense; how this has changed over time; which forms may be discerned in different spheres of life and society; and with what results. The main aim of this project is to build a comprehensive look on how the technological and social convergence of the media based on digitisation (trans)form processes of mediatisation and what are its consequences in online and offline social environments.

A comparative analysis of actions of three main types of actors (politics, civil society, private citizens) shall enable us to develop a typology of factors that shape the forms and modes of mediatisation of online and offline actions in different environments. In that perspective, the project addresses the question of whether the convergence of media serves social actors as merely a tool for a more efficacious coordination of their instrumental and communicative actions or it substantially redefines their understating of social actions and communications that can be observed in new mediatised forms of communicative and instrumental actions.

### REALIZATION IN 2017

The research group continued with its work on a joint article – we analysed the functioning of visible stakeholders in the field of LGBT and feminism in Slovenia. We were interested in the organizational (activist) and thematic (substantive) credo of the movements. The title of the article is “Feminism to be: Overcoming the framework of gender and redefinition of feminism in Slovenia”. On the basis of empirical research (analysis of networks) we examined the thesis that, for a difference of the past civil society activism of anti-systemic feminist and LGBT groups the new actors function with an aim to realise their own “distinctive imaginarium” – which fits the concepts that the new movements identify with (infrapolitics, politics, new social movement). We prepared a report on the module coordinated by the Peace Institute titled “Social movements, internetisation and alternative politics”.



### AIMS AND GOALS

The project deals with the processes of gender differentiation in the media industry reproduced through the media's convergence, conglomeration and commodification in the context of the rise of information and communication technologies. Departing from the finding about the lack of suitable epistemologies and methods to adequately address gender differentiation in the media, the project introduces theoretical starting points of the feminist political economy of communication which highlights the need for synergy of the macro, mezzo and micro levels of research or presumes structural and institutional analysis combined with the experiences of actors who work in the media industry or participate in it as consumers. The project introduces a feminist inclusive conceptualisation of gender which studies gender relations by integrating the perspective of intersectionality through which it identifies the intertwining of gender with ethnicity, sexuality etc. that produces discriminatory effects.

### REALIZATION IN 2017

The preliminary results of the research were published in journal *Teorija in praksa* (No. 3-4, 2017) series, in the thematic issue of articles (5) "Gender differentiation in the media industry" (ed. M. Pajnik), in which, on the example of television in Slovenia, we analysed reproduction of gender inequality at the crossroads of media politics, production and consumption. The articles were contributed by Mojca Frelih, Živa Humer, Dejan Jontes, Breda Luthar, Mojca Pajnik, Brankica Petkovič and Maruša Pušnik.

Within the framework of the project, two reports were published: The historical review of media policy in Slovenia from the point of view of gender (B. Petkovič, 35 pp.) and the Review of the Legal Regulation of Employment Positions in Slovenia, as a Basis for analyzing the Gender Differentiation of Precarity in Journalism (M. Hrzenjak, 24 pp.).

The research group conducted 21 interviews with journalists from selected TV stations, RTVSLO, POP TV and Planet TV on the basis of a questionnaire (several content sections: media policies and transformation of journalism profession; media, employment policies and working environment; organizational norms and values; working process; TV conventions). The data will serve as a basis for further analyzes that we plan to collect in the book, and the first article that relies on interviews has already been published in the journal *Public-The Public* (M. Pajnik, 2017).

We have prepared a methodological design for ethnographic research (M. Pajnik, M. Ribač), which is the basis for field work - observation of the production process on televisions (Ž. Humer, M. Ribač, M. Frelih) - which we started in December.

## Comparing Croatian and Slovenian Prostitution Regimes

### AIMS AND GOALS

Prostitution is a taboo topic in the former Yugoslav countries and engaging in sex work is criminalised in several countries, even if decriminalized (the case of Slovenia). The development of policy is ideological rather than empirically driven and is, in many cases, not informed by the human rights standards. Indeed, in both countries human rights abuses of sex workers are frequent but are not challenged and there is no sex workers organisation. There is little research on prostitution, particularly research that is based on narratives of sex workers. Further, there are no studies comparing Croatian and Slovenian prostitution policies and their impact on sex workers. This comparative research assesses commonalities and differences of prostitution policies in the two countries. It looks at if and how the differences are reflected in legal and public discourses and the narratives of sex workers. The research is focused on eliciting experiences of sex workers, as the most important source of information in designing and implementing feasible and effective policies. By undertaking research in the two post-socialist EU members which prostitution regimes fall outside the dominant frameworks, this study brings new perspectives to the scholarship on prostitution, which can make prostitution policies more inclusive. It questions the main concepts of victimhood vs. agency, work vs. violence in the context of specific cultural, economic and political circumstances of the two countries.

### AIMS AND GOALS

In 2014 the Fundamental Rights Agency found that sexual harassment (SH) was the most prevalent form of violence against girls and women, across the 28 EU member states. A promising new approach to the prevention of SH is targeting young people as bystanders, inviting them to notice and intervene in SH situations. In this project, developed in Portugal, Slovenia, United Kingdom and Malta, the researchers will develop, pilot, implement, and evaluate a school-based program for bystanders to prevent SH in high-schools.

Objectives are to increase knowledge and awareness of SH in students and staff; develop, pilot and deliver a training program for students and school staff to enable them to intervene in situations of SH, increase the motivation of bystanders to stop SH in high schools, develop a manual and materials adapted to each country, develop school policies and protocols on SH, compare the implementation and effectiveness of the program in the four countries.

### REALIZATION IN 2017

In 2017 we were active above all in the first and second work stream of the project. Background research for the project was finished. We explored the legal and political frameworks of fighting against sexual harassment in schools, we prepared and translated the manuals for educational activities for the bystander approach to sexual harassment. On the basis of manuals, the pilot workshops with students and teachers were carried out. We revised educational materials (lesson plans) on the basis of background information from the pilot and started with the organization of workshops in three schools in each of the participating countries. Website of the project with all the important informations and results of the project was prepared.
