WOMEN 20 YEARS AFTER BEIJING

Congress Centre Brdo, 13th and 14th November 2014

Year 2015 will celebrate the twentieth anniversary of adopting the Beijing Declaration and the Platform for action at the fourth World Conference on women in Beijing. Every five years, progress in implementation of the Beijing Platform for Action is reviewed and the review is conducted at the national, regional and global levels.

Slovenia, as a signatory state, has firmly committed itself to implementing measures that will continue to pursue the goals towards the greater gender equality. Gender equality is one of the cornerstones towards a just society. Twentieth anniversary is an opportunity to look back, to review what has been done and to look forward to the future.

The Conference *Women 20 years after Beijing* will be an excellent opportunity to discuss gender equality and the position of women in general, to find out what has been done and achieved in Slovenia and what is the situation nowadays in comparison to 1995. Special focus will be given to specific areas of concern defined in the Platform for action. The main events, policies, changes in legislation that have had an important impact on situation of Slovenian women and gender equality policy will be highlighted. We will also identify areas where a considerable progress has been made and areas where special attention still needs to be given in order to improve the situation of women in Slovenia.

Are we facing positive changes and greater gender equality nowadays or, on the contrary, the deterioration of social, political and economic circumstances that affected the lives of women and lead to several inequalities? As our focus is positively oriented we believe we can come together and make a common statement, including some concrete proposals.

The Conference is organized by the Ministry of Labour, Family, Social Affairs and Equal Opportunities and the Women's Lobby of Slovenia, in the framework of the bilateral cooperation of the EEA Financial Mechanism and Norwegian Financial Mechanism 2009 - 2014 for Slovenia.

We look forward to greeting you at the Conference *Women 20 years after Beijing* in Slovenia.



11.30 – 13.30 PANEL 2: WOMEN IN EUROPE

Beijing Platform for Action is the fundamental international instrument for implementation of women's rights and empowerment and it is binding for all European states. Platform for action contains a series of measures and is divided into 12 different areas of concern. The EU has been regularly monitoring the implementation of the instrument. Financial and economic crisis in Europe has led to the adoption of measures that have worsened the situation of women. Sometimes such measures are also influenced by tradition, religion and culture.

- What is the estimation of the progress made in the area of equality between women and men in Europe or in specific countries (Croatia, Iceland, Norway, Liechtenstein)? Has the situation of women improved?
- What was the progress in the area of gender equality in other European countries? What were the obstacles and how did we overcome them?
- What are the major setbacks encountered by women preventing us from achieving greater equality between women and men?

14.30 – 15.30 PANEL 3: FUTURE CHALLENGES

Year 2015 signifies an important year of global solidarity for women's rights. Based on the revised Millennium Development Goals a new development program will be adopted. In order to achieve this goal, relevant legislation and policies have to be adopted. - What kind of policies and measures are needed to change / improve the situation?



TOPIC 3: WOMEN IN PRIVATE LIFE (in Slovene only)	 Several changes happened to people's private lives in the past 20 years; i.e. changes in family life, structures of family, changes in gender roles and models. Is the current definition of family sufficient? What defines it and what is its role? Have those changes caused higher level of gender equality or even re-domestication? Slovenian women are overburdened with unpaid caring work in private life. There is a high demand for care services in Slovenia, especially in private sphere (e.g. care services for elderly, children, and household assistance). Several questions on equality arise while discussing unpaid and paid care services. Austerity measures in the area of social welfare cause additional pressure to families, in which women do most of the unpaid work. Unpaid work represents almost 40 % of Slovenian GDP.

Beijing's Platform for action remains a political challenge for a country which has committed itself to achieving greater equality between women and men and therefore to realizing adopted political commitments and international obligations. Areas, where women face several obstacles, still remain. Further stagnation or even regression in gender equality shall be prevented. Slovenian government needs to put forward already adopted obligations and show that gender equality issues are very high on our list of concerns. Women's manifesto 2014 will be a document with concrete proposals for the government and politicians who will be involved in the future gender equality policy. Our goal is that Women's manifesto 2014 will be taken as a core document and a basis for a common act in the area of women's rights and gender equality. Women's manifesto 2014 should also be a basis for our cooperation in putting forward women's demands as a part of European and global movement in structuring and auditing the UN development goals after 2015.
