GENERAL

Confirmation

- A) We confirm the receipt of the OSF funds for the year 2012 (grant period from January 1st to December 31st, 2011). The amount was 661,139.00 USD.

Introduction

The year 2012 was a turbulent year for Slovenia. Following early elections at the end of 2011, at the peak of the economic crisis, Slovenia obtained a new center-right government which immediately started imposing austerity measures. To secure public support for the measures and crush resistance the government portrayed the economic situation as worse than it really was, constantly referring to the possibility of an EU bailout system. In spite of the fact that addressing the crisis solely by strict austerity measures is not adequate the Slovenian government remained faithful to this approach which already resulted in a certain reduction of public systems (e.g. welfare state, universities, science institutes, public media, culture, health care), increase of poverty and precariousness of workers, and even in cases of hunger among school children. Some austerity measures were adopted in an openly discriminatory way, such as pension cuts that affected only certain categories of retirees. The governing structures also embarked on a mission to adopt as many laws as possible as quickly as possible with as little public discussion as possible. The National Assembly even adopted a unique law Slovenia has never seen before – a law by which 39 other laws from very different spheres of life were amended.

The lack of transparency of the legislative process, the lack of possibility of the people to have a say in governing public matters and the lack of legal certainty caused a significant decrease of trust in the rule of law and public institutions. The trust into authorities was further diminished due to a series of corruption, cheating and plagiarism scandals, criminal indictments and court investigations, involving various public officials (the prime minister, members of the parliament and mayors). These developments together with the growth of inequality were expected to inevitably lead to civic unrest as well as to increase of intolerance and xenophobia. In fact, in the last quarter of the year the dissatisfaction of the public with the governing structures culminated in mass protests across the country, with thousands of protesters demanding political elites to step down. Two protests turned violent, and at one of them Nazi groups were openly expressing their hatred.

Foreign media connected some of these protests with the presidential elections, however, the two events in fact had nothing to do with one another. The elections however resulted in defeat of the incumbent Danilo Türk and victory of Borut Pahor who became the first person in Slovenia to hold all leading functions plus terms as a member of the national and the European parliament. Pahor positioned himself as a supporter of the current government and many of its reforms, while Türk was highly critical both of the reforms and the government, and in particular the prime minister. The voters' turnout was 42 %, the lowest one so far.

Outstanding issues

Within this environment the Peace Institute (PI) both reacted to the developments in society at large but also continued to develop interdisciplinary research and critical stance towards issues within its main five field of work – politics, human rights and minorities, media, gender and cultural policy. As the two approaches overlap, the issues we have been working on were

constantly in the center of attention. For example, the issues of austerity, increased inequality and raising precariousness were addressed by a project "Transcontinental Cooperation in Addressing Labor Conditions and Labor Relations in the Times of Economic Crisis and Social Reforms" (funded by the joint initiative of Think Tank Fund and East East Partnership) and our long-standing program "Workers' and Punks' University" (led by students) which in 2012 focused on the topics of "Financialization" and "Double Crisis of Eurointegrations". The Peace Institute consistently followed the developments concerning the protests and in one of the key moments when it was not clear whether the protects will have any effects opened up a space for discussions about the claims of the protesters by organizing a public forum titled "The Protests – Why and What Now?".

Further, a very visible development in 2012 from the area of PI's work was the landmark judgment concerning the 'erased people', delivered by the Grand Chamber of the European Court of Human Rights in Strasbourg on 26 June 2012. The PI participated in the procedures before the Court as a third party and provided information and legal analysis of domestic legislation and practice to the attorneys (Anton Giulio Lana and Andrea Saccucci) of the applicants in the case. With this judgment the first compensations so far were recognized to the erased people. Moreover, the judgment was a pilot judgment in nature ordering the government to adopt an ad-hoc compensation scheme for all other erased people who were not applicants in this case. The success did not go unnoticed in the international NGO community as in 2012 the Peace Institute received two awards for its work on the issue of remedying the injustices of the erased people: *PILnet's 2012 European Pro Bono Award for exemplary partnership in the public interest* and *PASOS Think-Tank Achievement Award 2012*.

Also, for a number of years the PI has been a pioneer in gay and lesbian studies. The results of our work have been cited in the Family Code bill (adopted in 2011) which would have provided same-sex couples equal rights comparing to opposite sex couples, except in the field of adoption and assisted reproduction services. When conservative groups claimed referendum against the bill the Peace Institute staff were actively engaged in public discussions on the rights of gays and lesbians, pointing out the importance of human dignity, equality, diversity and non-discrimination. With the support of the OSF Rights Initiative we carried out a poster campaign and organized a range of roundtables on the stated issues under the title "Citizens in Diversity".

Projects and activities

In addition to the issues of erased people and the rights of gays and lesbians, in the field of **human rights and minorities** a number of other non-discrimination and anti-racism projects were carried out throughout the year, such as e.g. "RED Network Combating Racism, Xenophobia and Intolerance", a partnership of 17 organizations aiming at providing the information on racism and discrimination across Europe on one portal (www.red-network.eu). We also continued to provide the up-dates for the European Commission on the anti-discrimination legislation within the "European Network of Legal Experts in Anti-Discrimination Field" and continued to organize anti-discrimination seminars. In 2012 were involved with providing various legal and social studies for various European agencies (the European Commission, the European parliament and the EU Fundamental Rights Agency) in the field of fundamental rights and legislation in the field of access to justice. A very new initiative developed by the PI in 2012 was a mapping of statelessness in Slovenia, conducted in partnership with UN High Commissioner for Refugees (UNHCR).

In the field of **politics** a number of projects were continued in addition to the already mentioned projects on transcontinental cooperation in the field of labor relation and the program Workers' and Punks' University. By using Arendt's thesis about the break of western political tradition our work aimed at understanding, use and translation of some of the basic concepts of politics in the post-totalitarian age, deriving from a perspective that this thesis can help us understand

contemporary problems and with interpretation of some newer political categories. Within the politics field two PhD candidates were working on their dissertations, expected to complete their work in 2013.

Within the **media** field we continued to monitor, research and report on media policy and media practices in Slovenia, as well as on access of minorities to media. We published a book titled "Ours and Yours" written by historians Marko Zajc and Janez Polajnar. Also, we organized a number of public events in the media field and published two issues of our MediaWatch journal (42th issue in May/June and 43th issue in December 2012), both comprising 120 pages and more than 50 articles. Further, we participated in a number of regional and international networks in the media field and built partnership with relevant organizations abroad with a purpose to incorporate our work in regional and international initiatives on media freedom and accountability, and freedom of information. We also continued our engagement on issues of media ownership, its transparency and their impact on media pluralism, quality and independence.

Further, in the field of media we were engaged in an innovative and significant research project titled "Mig@net: Transnational Digital Networks, Migration and Gender" funded within the 7th Framework Programme of the European Commission. The project addresses the question of participation of migrants in transnational digital networks by employing innovative methodologies. The focus of the project is on the ability of migrants to access and co-produce diverse digital networks, and use them to promote their own needs, as well as on possibilities for the promotion of intercultural dialogue and cooperation. The project is interdisciplinary and cross-cutting in relation to our work done in the previous years concerning trafficking, labor migration and precariousness of labor migrants.

In the field of **gender** we embarked on an interesting issue of the role of men in the gender equality in a project titled "Study on the Role of Men in Gender Equality in Europe". The project aims at better understanding the situations of men in education, family life, on the labor market, in health and tries to integrate a perspective of critical studies of masculinities in the gender equality research and policy strategies. In the field of gender we also focused on the question why breakthroughs in domains such as the level of education and employment in once masculinized judiciary, public administration, medical professions and others do not result (yet?) in a more balanced division of political power and responsibilities. This question was addressed within the project "Gender Structure of the Contemporary Slovene Society and Gender Positioning in the Field of Politics", funded by the Research Agency of the Republic of Slovenia. We also worked on complex inequalities, specifically the intersection of gender and ethnicity, as addressed by the project "Gender and Ethnic Discrimination from the Perspective of Complex Inequalities". In addition, we further worked with and supported the Rwandan Nyamirambo Women's Center within the "Women for Women" project.

Finally, in the field of **cultural policies** we worked on analyzing the situation of writers and translators (which intertwines with our work on increased precariousness of workers addressed under *politics*). The aim was to examine the situation of culture workers as defined by the publishing industry and by the public support mechanisms. Further, we also worked on raising awareness among the public and local authorities about the important role of culture in development strategies for third world countries and to involve more local authorities in seeking out town twinning opportunities to further development.

A very important cross-cutting program of the PI is the **East East – Partnership Beyond Borders**. In 2012 four sub-projects were carried out within this program that complemented our on-going projects. Among the four sub-projects the one on comparing media reforms stands out as it hosted participants from the Western Europe, Western Balkans, Russia, USA, Latin America, Middle East, North Africa, and East Africa.

In the field of secondary dissemination our **website** was continuously up-dated by our web-site manager and our **library** continued to be available and open for public, attracting new members every year. In addition to our regular activities, we also undertook the organization and hosting of the **20 anniversary of the OSI Slovenia** which included cultural program, speeches of honorary guests and bestowing of **Živko Pregl Award** (in cooperation with Slovene Philanthropy).

Fundraising

Throughout the year we cooperated with a number of OSF programs: The Office of the Regional Director for the Western Balkans, Human Rights and Governance Grants Program, Think Tank Fund, East East Partnership Beyond Borders, Rights Initiative. In 2012 we also signed an implementing partner's agreement with the UNHCR. In 2011 we experienced more difficulties than usually with regard to obtaining European Commission funding which encouraged us to look for funding even more intensively in 2012. The efforts paid off as we were successful in obtaining five European Commission-funded projects in the field of free movement, media, gender and trafficking, as well as racist and populist discourses.

Aims and goals

The project is an adapted version of the bigger planned comparative project. It aims at understanding, use and translation of some of the basic concepts of politics in the posttotalitarian age, by using Arendt's thesis about the break of western political tradition. This thesis can help us understand contemporary problems and with interpretation of some newer political categories after the 1989 break with socialism, with understanding of some phenomena of global socio-economic policies and new forms of collective violence, for example. Research will focus on the notion of politics, policy and the concept of the political as related with some other chosen categories, such as power, revolution, society and the social, economy, sovereignty, violence. history. totalitarianism, etc. We will look for the streams of thought that have influenced the consideration of the break in tradition thesis and analyze their importance for contemporary situation in the 20th and 21st century. The relevance of the break of tradition thesis will be checked against the critical analysis of selected political concepts in the concrete post-socialist contexts.

Aims and goals

The project is a follow up part of the project Quing: Quality in gender equality policies in EU and Turkey. It uses its methodology and database, but it also goes beyond that with additional fieldwork. The follow up thus represents both an enlarged dissemination and publication of the results of the project, and the continuation of analysis through a PhD project on the special case of Turkey. It focuses on the influence of Europeanization on the religious discourses in the public gender equality policies and politics of intimate citizenship in Turkey. The final result will be an interpretation of the EU enlargement strategies from the perspective of the concept of Europeanization and EU-ization, with the particular focus on the relationship of the EU towards Turkey and Islam.

Ana Frank, a PhD candidate, has been doing her concluding research in Turkey (ongoing from February) on the topic of her dissertation: *The influence of Europeanization on religious dicourses in framing gender equality and intimate citizenship policies in Turkey*, consisting of policy analysis and historical contextual research. She is now writing her doctoral thesis. Focusing on discourses and policy framings of main political and civil society actors, the research aims at mapping the influence of Europeanization on changes in gender equality policies in the Turkish national context. Ana has also participated at conferences and is preparing publications on the topic.

Aims and goals

The project is a follow up part of the comparative project Violent intersections, comparing Yugoslav and Rwandan case of collective violence and post-conflict strategies. It consists of three parts. The first part represents dissemination and publication of the results of the basic project, the second, as well as the third one, are a continuation of the analysis (PhD researches) on two topics: 1.) on the issue of transitional justice – it researches the public narratives of the past in the framework of transitional justice processes in the case of Bosnia and Herzegovina; 2.) on the issue of victimization – it researches narrative constructions of victimization and victim identities.

Realization in 2012

The young researcher Jovana Mihajlović Trbovc continued research work on her PhD thesis Public Narratives of the Past in the Framework of Transitional Justice Processes: The Case of Bosnia and Herzegovina, which is coming to its final phase. There have been changes in the plan of work in 2012 as one PhD candidate (Tamara Banjeglav) under the mentorship of Vlasta Jalušič went to finish her PhD in Graz. A new project proposal, based on the Violent Intersections results, was prepared and submitted to the EU HERA tender in May.

At the 20th anniversary of the erasure, we organized a press conference and called for the National Assembly's Commission for Petitions to hold a session at this occasion. Throughout the year we offered legal counselling and representation to the erased and monitored the implementation of the 2010 amendments to the act concerning the status of erased persons. Between June and December, after the European Court of Human Rights decided on the Kurić case, we carried out an extensive information campaign explaining the meaning of the decision. In July, we launched a website The Erased: Information and Documents, in three languages.

After the public launching of the RED System the partners focused on providing a regular update of the RED early-warning system, possible breaking news reporting (exceptional reporting on emergency situations) and keeping RED Atlas informed on the situation and trends in the relevant EU countries. In August 2012, the network produced a report on far right parties and relevant trends in the RED Network member states.

On the invitation of the Bosnian community within its project on building communication capacities for minority communities from former Yugoslavia, we led a number of workshops between February and May 2012 to empower activists from the Bosnian, Croatian, Montenegrian, Macedonian and Serbian community for developing and maintaining a joint web information portal (sokultura.si). Within this initiative we have organized a meeting between editors/journalists of the mainstream Slovenian media and activists of the communities from the former Yugoslavia, as well as a visit of the representatives of the minority communities to the editorial office of the web portal (Multimedia Centre, MMC) of the public service broadcasting RTV Slovenia. Based on these activities, an initiative has been lauched to establish a web site within the web portal MMC dedicated to minority communities from the former Yugoslavia in Slovenia. We have participated in various public debates on hate speech and negative portrayal of ethnic minorities, including the regional symposium on combating hate speech in Europe, held on 26-27 March 2012 at the European University Institute in Florence.

Being a part of European networks of non-governmental and research organizations engaged in the field of media and cultural diversity, we have contributed to the validation of the findings of the European research project on media and migrants MEDIVA, through a contribution at the final conference on 15 June 2012 in Brussels. We have also developed several project proposals within the European partnership in this area and submitted it to the European Commission.

Within the activities of the Peace Institute aimed at the improvement of the status of the erased residents in Slovenia, we have developed a media archive of reports on the

issue published in the main Slovenian media in the past 20 years, including in the archiving efforts the media, journalists and photographers themselves.

We have also submitted suggestions to the Ministry of Education, Science, Culture and Sport within the process of adoption of the National Resolution on the Language Policy in Slovenia, advocating for measures to provide protection and promotion of the use of Roma language and languages of minorities from the former Yugoslavia in the public media. Our suggestions were considered and the measures included in the proposal of the Resolution.

Aims and goals

Main goal of this project was marking of the 20th anniversary of the establishment of the Open Society Institute–Slovenia, a non-profit foundation which operated between 1992 and 2000 as a part of the global network of Soros Foundations, providing support to civil society, arts and culture, high education, publishing, independent media and other areas in Slovenia.

Realization in 2012

An important part of the project was Živko Pregl Award which was presented for the first time; it was established on the initiative of a group of staff members of the Peace Institute, the Slovenian Philanthropy and former Open Society Institute–Slovenia. Živko Pregl was co-founder and Vice President of the Slovenian Philanthropy and president of the Board of the Open Society Institute–Slovenia. Award was presented to its first recipient Irfan Beširević, an activist who works through Social Centre Rog in Ljubljana, Invisible Workers of the World and Civil Initiative of the Erased Activists. An afternoon panel with five speakers discussing the economic, political, and cultural situation of the 1990s was also a part of the anniversary program.
