# Violent intersections: dynamics of societal and political elements of collective violence and mass crimes and their consequences – Yugoslav and Rwandan case

# Aims and goals

The project aims at a deeper understanding of conflict escalation in transitional periods, how such conflicts eventually cumulate in massive violent events and what consequences do these events and their legitimization have for the post conflict societies.

#### Realisation in 2008

Theoretical framework was elaborated: (re)reading and elaboration of a set of major studies on the problem of gendered, racialised and ethnopoliticised conflicts, political theory approaches to the issues of massive atrocities, and approaches to justice, guilt and responsibility. To provide the ground for the analysis of intersections, special attention was paid to the studies on discourses of symbolic collective identities. A field study visit to Rwanda was carried out.

# Aims and goals

This is the first project on immigrant and urban Roma population in Slovenia. It aims at going beyond the dominant discourse on Roma population, depicting them mainly as a (cultural) "social problem" by pointing to their political rights.

The goal of the project is to bring the problem of erasure and the erased closer to solution and to increase the capacity of local NGOs to address human rights violations in Slovenia.

#### Realisation in 2008

In 2008 we continued with the implementation of a three year project. We carried out legal assistance to the erased, assisted Studio Lana at representing the case of erased before the European Court of Human Rights, continued with field research on erasure with interviews and transcripts, encouraged the authorities to resolve the problem, raised awareness, and organized public events. We prepared detailed recommendations for measures for resolving the erasure.

# Aims and goals

The main goal of the project is to build a capacity of lawyers for pro bono practice in matters of vulnerable groups in need of legal assistance, when they are not eligible for or able to obtain free legal aid.

#### Realisation in 2008

We started to implement this project in June 2008. First we prepared an on-line survey in order to carry out a research on the existing pro bono work, invited attorneys to become members of the pro bono network, gathered materials for analysing conditions for development of pro bono work in Slovenia, established a clearing house to serve as a contact point between lawyers, NGOs and vulnerable groups, and presented the project and the clearing house to NGOs.
