12:15 – 13:50 Reasonable accommodation for persons with disabilities by the actors of criminal and misdemeanour justice systems

The issues of removing numerous existing physical barriers, as well as barriers to effective communication hindering access to victims' rights for persons with disabilities, and ways of providing them effective support in judicial proceedings will be discussed by the panel.
